Introduction

The Charter of Fundamental Rights of the European Union brought together the most important personal freedoms and rights enjoyed by citizens of the EU into one legally binding document. The Charter was declared in 2000, and came into force in December 2009 along with the Treaty of Lisbon. Since then, the European Union has gone through a series of critical situations. After the sovereign debt crisis in 2008, the refugee crisis highlighted by the war in Syria (2011) yet with additional causes such as climate change or the fragility of states in Africa and Brexit, in 2020, with Covid19 pandemic, the EU would experience a shock with a hybrid threat to health of the people and, more recently, with the return of the conventional threat, as is the case of the Russian-Ukrainian War on the periphery of Europe. The challenges posed today to Human Rights in the EU are more decentralized and with potential risk of the not respect their principles. Related with ethnic identity, Religion, the most important social factor of the human history, become a central issue in the assessment of HR in the EU. Despite of the secularization process that occurred in the modern time, with the growth of radical right-wing and far-right parties (France, Italy, Portugal, Greek, Austrian, Hungary, Kingdom, Romania, Sweden, Poland, Germany), religious issues has returned to the political agendas of many European states.

The fragile dialectic between state sovereignty and respect for multiculturalism, which includes the various religions present in European territory, is one of the most relevant topics for various scientific and disciplinary areas. The importance of disseminating studies and academic discussions on this subject from a multidisciplinary perspective – law, philosophy, theology, sociology, anthropology, religious studies, international relations, European studies – is still necessary and can contribute to better governance policies in the EU in terms of Human Rights.

In order to respond to these major current challenges, the editors intend to bring together contributions from authors of different scientific areas, whose topics may arouse the interest of academics who work with this issue. In Europe at an economic, political, social, humanitarian and geopolitical crossroads in which we live, this book intends to contribute to the valuation of the scientific knowledge, in addition to opening new epistemo-methodological analyses in the domain of the intellection of the EU, Human Rights and Religion.

Objective

The general objectives of this book are:

- Explore trends in human rights abuses in the EU
- Assess normative evolution in terms of human rights in the *acquis communautaire* and among member states.
- Evaluate the interreligious and ecumenical dialogue in promoting the homogenization of human rights
- Present the current state of governance;
- Investigate /examine situations of violation and disrespect of human rights in the European Union
- Assess the acceptance by religions of European decisions on human rights
- Sightsee refugee reception and governance responses;
- Publish recent studies in the various disciplinary areas that intersect the European Union, Human Rights and Religion;
- Contribute to new lines of research emerging from European Union, Human Rights and Religion governance

Paulo Mendes Pinto, PhD in Cultural Studies, since 2021 is Dean of the Lusófona Faculties in Brazil. He is the coordinator of the Religions Studies Department at Lusófona University, Portugal (since 2006). He was Ambassador of the World Parliament of Religions (2015-2018) and founder of the European Academy for Religions (2017). He devotes part of his work to study issues related to the relationship between the Modern State and religions. He coordinated the "Republic and Religions" seminar held by the Presidency of the Portuguese Republic, in 2005, and was the scientific coordinator of the "Religions: History - Texts - Traditions" project, in 2006. In 2017, he coordinated the project "Roadmap for Interreligious Dialogue", supported by the Portuguese Secretariat of State for Citizenship and Equality. With the Islamic Foundation of Palmela, he created the "Advanced Formation for Islamic Leadership", directed to Imams acting in Europe. He coordinated the first phase of the Portuguese participation in the "EUREL - Données sociologiques et juridiques sur la religion en Europe" project, from the Robert Schuman University and the CNRS. And also is the scientific coordinateur of the european projects "PROSECUW - PROtection and SECUrity for places of Worship" (2020-2023), "CEAR - Community Engagement Against Radicalisation" (2019-20), and "RE-THINK – Alternative Narratives to Violent Extremism" (2018-2020).
